With the dry weather and low water conditions so far this season many members have left their salmon rods at home and ventured out for trout instead. So despite some reports of kelts caught on Loch Achonachie as usual at this time of year, and a few mistaken identities, the bulk of fishing has been trout orientated both on the lochs and the rivers.

Four pairs from our club came forward to contest Beauly Angling Club's annual competition on Loch Watten last month. It can be a challenging loch to fish though it produces some beautiful trout, but this year's outing was described by Beauly AC stalwarts Frank Durdle and Neil MacKenzie as their best ever competition day on Watten.





### **MEIG PONTOONS**

Another ultra-high water level in the third week of December lifted the pontoons high above the level of the pier levering the wheels of the bridge out of their runners. A huge amount of water was spilling over the dam wall and again the flow in the loch twisted the bridge off the pontoon deck.

Whilst it is nigh impossible to prevent this kind of effect on our pontoons modifications designed by Lewis Ross have been fabricated and fitted to prevent the bridge being twisted off the pontoons in future.

The heavy duty work to restore them to their proper positions was completed in the first week of the season by Lewis and Ian MacPhail working together with a telehandler. Once again the club is indebted to these guys for their outstanding work in difficult conditions.



## VANDALISM

Sad to write that we had several instances of vandalism, destructive behaviour and fihign wihout permits in April & May.. The damage some people are prepared to do just for the sake of a few pounds to buy a permit & hire a boat Thanks to club members and passing members of the public for reporting these to us. Repairs have now been completed. So someone in a big vehicle ripped the gate off at South 1 Beat of the Upper Conon; someone else took an angle grinder with them to cut the stainless steel boat painters off at Meig; padlocks were destroyed at North 1 beat on Upper Conon. Any information about these destructive acts would be welcome if you hear anything.





#### **MISUSE OF BOATS**

This was one of the daftest things we've seen, presuming it wasn't an act of vandalism this was perhaps someone trying to fashion an anchor our of a massive rock? ## FISHING RELATED POLITICS

There are a number of issues relating to the seemingly endless planning applications by companies seeking to exploit the drive for net zero which will have major impacts on our nation's waterways.

Ness District Salmon Fishery Board are active with others in raising objections. Applications to extract huge volumes of water from Loch Glass for hydrogen production are worrying too. A current petition to Scottish Government can be read and signed, if in favour, at the link below right.



#### Under consideration PE2159: Halt the production of hydrogen from freshwater

Calling on the Scottish Parliament to urge the Scottish Government to place a maratorium on the production of hydrogen from freshwater until scientific studies are undertaken to understand the impact on the environment, local economies and society.

#### **Background information**

Green hydrogen is touted as a replacement for fossil fuels. Hydrogen production requires extreme and unsustainable volumes of fresh water. Borehole water is seen as a source. Anunfacturing takes 25 to 40 litres of desailnated or freshwater to produce 1kg of hydrogen. 1kg of hydrogen will power a class 1 or 2 Large Goods Vehicle for 6 miles. One plant under development plans to use 500.000 litres of water per day to produce 12, 200kg of hydrogen. Similar plants are proposed/under development. Water will be extracted from a very wide geographical area depending on ground conditions and regional rainfall. Water is a major element of life and is in short supply in many areas. The volumes to be extracted will adversely impact the countryside, local industries, agriculture, fishing, and households, and possibly affect flooding. Extracting water will cause serious adverse impacts on aquatic life.

Responses to my enquiries show little knowledge of the volume of water used and I have seen no scientific studies to identify possible adverse consequences.

We are indebted to the many Councillors on the planning committee who contributed to the debate, which resulted in the councillors voting to raise an objection. This was absolutely the right decision, Loch Ness is far too important to be thrown under the Net Zero bus.

A planning application has been submitted for a hydrogen production facility powered by renewable energy near Loch Glass, Scotland. The proposed development, which includes an electrolyser plant, aims to produce green hydrogen using electricity from renewable sources. The project is expected to reduce CO2 emissions and create jobs. Public consultation events have already taken place, and the application is currently under review by The Highland Council.

## CLUB MEMBERS ABROAD SPECIAL FEATURE - FISHING NEW ZEALAND

Having been lucky enough to have fished in New Zealand myself I was keen to get a report of any member's experiences there. Club member Pete Bene was there this year and emailed us this account from South Island, NZ.

Stephen, the attached pics are of Richard Ormston & myself, my son Liam all club members from various trips to NZ over last few years including this one. You asked for some pics and a few words hope this is what you were looking for. These pictures cover a good portion of the South Island and show the various landscapes and in most cases the clarity of the water is excellent. The fish are not as numerous as our waters but are much larger as you know and readily take dry flies as well as nymphs. The traditional Kiwi style being a nymph dropper tied to the bend of a dry fly and fished to spotted fish but in cases of bad glare, we just fish blind.

When fishing the rivers it helps if you have a "spotter" higher up or on opposite bank then you work as a team keeping each other informed as to what you're seeing, again glare being a problem but not always for both sides. On the down side the weather can be a major spoiler with strong winds and flooding which has been a big problem this trip with rivers being up and down and coloured with it resulting in fish losses, a lot of fish running down to lakes or in lowland rivers running down to the sea. As for lakes, in the shallow deltas we cast to cruising fish if glare allows or blind if not. I have found our traditional style loch fishing works very well as do buzzers under a dry.

I especially like standing in the boat spotting big browns and rainbows cruising the shallows then casting in front of them, but fishing blind in slightly deeper waters is also productive.



If any members are planning on a fishing trip to South Island NZ then they can contact me if they want any information also there is a book by John

Kent giving a comprehensive break down of fishing in South Island and another for North Island. However, I only know South Island. *Well it's a great place to know Pete and many*

# So the message to all is – it's time to renew if you haven't already done so and let's all get out fishing again!

**FOLLOW THE RULES** An **updated rules document for season 2025** is now up on the website and you can download it from the front page. I can also send it to you by email. You need to remember especially if salmon fishing that **treble hooks are not allowed** so as to ease safe catch & return. So it's time to get busy with some split rings and double or single

hook replacements or just get your snips out.

Safe use of the Loch Meig pontoons has been highlighted to everyone before but here's it again on the next page. Remember it's a Scottish summer, so if you're booking a boat out it's always wise to take a bailing bucket of some kind with you ! The committee plans to fit bilge pumps shortly but meantime – take a bailer.



## **7 ESSENTIAL PONTOON RULES**

1Take care using the pontoons

2 One angler to unlock the boat and row to the slipway

3 Load up and fix on any outboards etc. at the slip way **not on the mooring** 

4 Take care of the keys – they have a floatation key fob attached but keep them safe please


5 Return your boat securely as above

6 Fasten the chain at the top of the bridge

7 RETURN THE KEYS TO CONTIN

AND HAND IN YOUR CATCH RETURN

PLEASE LEAVE THE BOATS IN GOOD ORDER WHEN YOU'RE FINISHED HOPEFULLY LOOKING LIKE THIS.
